

Project Summary Information

1. Housing Services:

- a. Housing Administration – cost to administer the housing program
- b. Housing Rehabilitation – cost associated with the rehabilitation of owner-occupied single-family dwellings
- c. Lead-based Paint Inspections and Clearances – cost associated with the inspection of homes constructed prior to 1978 to determine if lead-based paint is present
- d. Paint Program - provide paint and supplies to volunteers and homeowners for self-help projects

2. Public Services:

- a. City of Springdale Transportation Program: Provide low-income elderly and handicapped Springdale citizens with two taxi coupons quarterly. Each coupon has a face value of \$40.
- b. House of Hope Rescue Mission: The House of Hope is a "Day Shelter" for the homeless and needy in Northwest Arkansas. Provide a place where people can come for shelter from the cold or heat.; receive snacks , water and a hot meal while at our facility, help with counseling, job searches, and showers. Provide a place for clients to do their laundry free of charge and a place they can receive mail to stay connected. Clients can receive clothing and food from our pantry. Provide basic needs of individuals in our community who cannot provide for themselves.
- c. Bread of Life: Devoted to serving people who find themselves in crisis situations within an atmosphere of respect and compassion. Provide three (3) days of food and personal hygiene items to clients per month. Provide limited financial assistance to clients who have temporary situations which could result in homelessness in the Springdale area. This support could include either rent or utility assistance with verifiable documentation.

- d. Court Appointed Special Advocates: To provide quality volunteer representation for abused and neglected children in the court system. Recruits, trains and supervises CASA volunteers who advocate on behalf of foster children to ensure they are safe, happy and receiving the appropriate medical, psychological and education services.
- e. Credit Counseling of Arkansas: Improve quality of life through financial education, credit and housing counseling, and debt management services. Provide counseling during financial crisis (foreclosure prevention, eviction, collections) offering free education of financial responsibility (banking, budgets, debt reduction) and improving quality of life, homeownership, retirement savings and financial literacy.

3. Program Administration:

- a. Cost associated with the general administration of the Community Development Block Grant Program.
- b. Cost includes but not limited to: staff cost, travel and training, required newspaper ads, etcetera.

Ms. Kathleen Barta,

Thank you for your response for public comments.

I hope the chart below helps to explain how the grant will be disbursed by activities.

General Program Administration:

You mention you thought the "administrative element is too large". If you are talking about the General Program Administration budget. It is set at \$50,000. Based on HUD guidelines the General Program Administration budget could be \$166,119 or 20% of the entire grant allocation amount. This includes staff cost to administer the Community Development Block Grant Program such as: staff cost to prepare all required reports and plans such as : Action Plan, Consolidated Plan Amendments, Monthly and quarterly financial reports, semi-annul and annual financial reports, environmental reports, audits, travel and training, publication of newspaper ads, and other requirements of the Action Plan or Consolidated Plan. During the 2016 Program Year the city will be required to have an Affirmatively Furthering Fair Housing study performed. The 2015 budget was set at \$50,000 but, less than \$25,000 will be disbursed for General Program Administration. The budgets are sometimes set higher than necessary, because, I cannot exactly predict what will be required the next program year.

Housing Program Administration:

Is set at \$90,000. This includes staff cost to administer the Housing Services Program such as: staff cost to review and process applications for housing services, write the bid specs for all housing rehabilitation projects, track housing related projects and expenses, prepare environmental reports, conduct Housing Quality Standards of all homes qualified for the Housing Services Program, conduct daily inspections of projects in-progress, prepare and process all invoices related to housing rehab projects, prepare contract documents, file Deferred Loan Agreements, travel and training, publication of newspaper ads, vehicle fuel and maintenance, provide tools and equipment for volunteers. The 2015 budget was set at

\$90,000 but, less than \$90,000 will be disbursed for Housing Administration and the 2015 Program Year was 18 months long versus the normal 12 month period.

10.5% of the grant was awarded to non-profit agencies

71.2% of the grant will be awarded to homeowners for Housing Rehabilitation projects

I especially appreciate the breakdown of the Housing Program in terms of administration and grants. It is much clearer than just a combined amount for the program.
